DETAILS OF INVESTIGATION:

On 05-30-99 at approximately 1456 hours, I was dispatched to 4943 Wildflowers Dr on report of a possible cold burglary.

Upon arrival, I contacted the RP who identified herself as JESSICA RUTH GONZALES. JESSICA RUTH GONZALES stated she believed someone had entered her home and changed the lock on her front door. She suspected her estranged husband was responsible for it.

JESSICA RUTH GONZALES stated that she and her husband, SIMON JAMES GONZALES, were in the process of a divorce. He had been living outside the home since January of that year.

JESSICA RUTH GONZALES advised that she had recently filed for a restraining order against SIMON JAMES GONZALES. She had feared that once he was served, he would try to retaliate against her. She had taken her children and went to Denver.

JESSICA RUTH GONZALES told me that she and SIMON JAMES GONZALES had arranged for him to pick the children up that day. She had called SIMON JAMES GONZALES that morning. She told him that he could not pick up the children that day. SIMON JAMES GONZALES advised her he would still pick them up and told her he would be

there in a few minutes.

JESSICA RUTH GONZALES stated she was not concerned because she and the children were in Denver at the time she had called. At approximately 1330 hours that day, she returned home. She stated that her key no longer worked in the door.

JESSICA RUTH GONZALES suspected that SIMON JAMES GONZALES had come over and changed the locks. She had the doorknob removed and replaced. She showed me the replaced doorknob. I observed that her house keys no longer operated the lock. The doorknob appeared new and there were no scratches near the keyhole indicating use. The doorknob was taken into my custody and later held as evidence at the Castle Rock Police Department.

JESSICA RUTH GONZALES showed me a copy of the restraining order she had filed. The order was found to be valid, however, JESSICA RUTH GONZALES was not sure if SIMON JAMES GONZALES had been served. A proof of service could be verified.

I contacted SIMON JAMES GONZALES via telephone. He advised that he had placed the new locks on the door of the residence. SIMON JAMES GONZALES stated that the house belonged to him and that he wanted it locked to protect his belongings. SIMON JAMES GONZALES advised he had not been served with a restraining order.

JESSICA RUTH GONZALES later contacted me. She advised she had spoken with the process server and that he had advised he had been unable to serve SIMON JAMES GONZALES the order.
